

VACANCY CIRCULAR

1. It is proposed to fill up the vacant posts of Principal Private Secretary, Level -11(Rs. 67700 - 208700), No. of Post -01(One), Private Secretary, Level -7(Rs. 44,900- 1,42,400), No. of Post -01(One), Upper Division Clerk, Level -4 (Rs. 25,500 - 81,100), No. of Post -01(One), listed in Annexure-I in the Regional office of the Ministry of Environment Forest and Climate Change Bhubaneswar from amongst officials of Central Government or State Government or Union territories or Govt. Undertakings or Govt. Research Institutions or Universities on deputation. The details of the eligibility conditions for the posts to be filled up on the deputation basis and the proforma for the application can be seen at Annexure -II of the vacancy circular on the website of the MoEF&CC, Govt. of India at www.moef.nic or can also be obtained from the Regional office, MoEF&CC, Bhubaneswar.
2. The terms and conditions of the candidates selected for appointment on deputation basis will be governed as per the conditions laid down in the Government of India, Department of Personnel & Trainings OM No.6/8/2009-Estt., dated 17.6.2010, as amended from time to time.
3. The period of deputation will be initially for three years and is likely to be extended up to five years as per guidelines of DOP&T. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding the appointment in the same or some other Office/Department of the Central Government shall ordinarily not exceeded four years for the post of Principal Private Secretary and three years for the post of Private Secretary and Upper Division Clerk. The Maximum age limit for approxinant of deputation shall not exceeded 56 years as on the closing date prescribed for receipt of application.
4.
