The applicant vide letter dated 10th June, 2022 has requested for issuance of subsequent NOC for the additional import quantity of Lead Scrap as per the revised norms in the 110th meeting of EC. The applicant has been granted permission vide letter dated 9th June, 2021 & 20th January, 2022 for import of 2,400 MT (1200+1200) of Lead scrap. The production in FY 2019-20 is 5,008 MT & 2020-21 is 3,770 MT. The applicant has also been granted new permission for import of 4,028 MT vide letter dated 6th May, 2022.

1.6. M/s Nile Limited, Chittoor, Andhra Pradesh (F.No. 23-139/2014-HSMD):

The applicant vide letter dated 17th March, 2022 has requested to include Waste & Scrap of Lead Acid Accumulators, Lead powders & Flakes and other Lead Waste in the previous permission letter granted for the import of 17,500 MT vide letter dated 16th September, 2020 of Lead Scrap (as per ISRI Code: Radio, Racks, Ropes, Rails, Rents, Rakes, Relay and Rains). The applicant has also been granted extension of validity period of previous permission up to 16th September, 2023 vide letter dated 15th March, 2022.

The matter was discussed in 113th Meeting of EC held on 25th & 26th April, 2022 and the recommendation of committee is as follows:

" The EC deliberated upon the proposal and recommended to include the Lead Acid Accumulators in permission granted for the import of 17,500 MT of Lead Scrap (as per ISRI Code: Radio, Racks, Ropes, Rails, Rents, Rakes, Relay and Rains) vide letter dated 16th September, 2020. However, for inclusion of Lead powders & Flakes and other Lead Waste, EC was of the opinion that waste details and pollution control measures should be submitted by the applicant for further deliberation on the matter in next EC. "

Accordingly, letter for inclusion of Lead Acid Accumulators was issued and applicant was asked to submit **waste details and pollution control measures for inclusion of Lead powders & Flakes and other Lead Waste.**

Now vide email dated 10th June applicant has submitted the details.
