1.1 M/s Gravita India Ltd.

The applicant has two units in Gujarat one in Gandhidham and other is in Mundra. Ministry has granted permission for import of 18,166 MT of Lead Scrap including RAINS to Gandhidham unit vide letter No. 23/52/2017-HSMD dated 7th May, 2022 and for import of 1,000 MT of Lead Scrap excluding RAINS to Mundra unit vide letter No. 23/77/2022-HSMD dated 20th June, 2022. Now Applicant has requested to transfer of import permission of Lead Scraps of Gravita Gandhidham unit to Gravita Mundra unit. They have further stated that that they have not imported nor booked any Lead Scraps against existing Import Permission of Gandhidham unit. Also, they will close their Gandhidham unit after consuming existing Raw Materiel inventory and as soon as the Ministry transfers this import permission to their Mundra Unit.
